## AWARD DESCRIPTIONS

### Associate Member of the Year

Awarded to an individual Associate AIA member who best exemplifies the highest qualities of leadership and has demonstrated unparalleled dedication and commitment to the AIA LRGV Chapter, the community, and to the profession of architecture.

### Artisan Award

Awarded to a team or individual that has collaborated, assisted or impacted LRGVAIA Chapter members on built project that helped elevate the quality and experience of the design.

### Emerging Professional – AIA Member

Awarded to an individual for professional achievement and leadership by architects who are in their first 10 years of practice after licensure.

### AIA LRGV Honorary Membership

Awarded to an individual of esteemed character who are not eligible for architect or associate membership in the organization but who have given distinguished service to the profession of architecture.

### Citation of Honor – Project

Awarded to a built project of the most exemplary design quality.

### 25 Year Award – Project

Awarded to a project of enduring significance. The award recognizes one building completed 25 to 50 years earlier that has stood the test of time by retaining its central form, character, and overall architectural integrity.

### Architecture Firm of the Year

The Architecture Firm Award is the highest honor that AIA LRGV can bestow on an architecture firm for outstanding contributions to the community, profession, and/or the creation of distinguished architecture.

### Contractor of the Year

Awarded to a contractor whose activities make significant contributions to the goals of the architectural profession for improvement of the natural or built environment in The Rio Grande Valley and should show a collaborative nature in his or her contribution to projects through craftsmanship, management, and relationships with the architect, sub-contractor, and the community.

### Consultant of the Year

Awarded to design consultant for outstanding contributions to the community, profession, and/or the creation and support of distinguished architecture.

### AIA LRGV Citation of Honor

Awarded to groups or organizations outside the profession whose activities make significant contributions to the goals of the architectural profession for improvement of the natural or built environment in The Rio Grande Valley, Texas. The Citation of Honor may also include individual artisans. The artisan nominee should show a collaborative nature in his or her contribution to projects.
